Our charge for direct cremation (without funeral ceremony) includes:

- Basic services of staff
- Removal of deceased to refrigeration / holding facility and crematory within Broward, Palm Beach, and Miami-Dade County
- Alternate care including refrigeration
- Cremation
- Processing, Inurnment & Priority Express Mailing within the State of Florida (Multiple shipping locations will have additional charges)

If you want to arrange a direct cremation, you can use an unfinished wood box or an alternative container.

Alternative Containers may be made of materials like fiberboard or composition materials (with or without an outside covering).
